Early Head Start Grant – Lee County: Terry Gentry reported that the application for a grant to supply Early Head Start services in Lee County was completed and submitted in time to meet the deadline of November 30, 2018. The submission of the grant application was preceded by numerous requests to the Lee County School System to make sure that we were not competing for the grant with Lee County. Allen Couch explained the results of the phone poll which was 8 voting to proceed with the application. A copy of the application is attached.

Revised Organizational Chart: William Sturgill presented a proposed change to the Organizational Chart of Kids Central Inc. The proposal would place the Comptroller under the direct supervision of the Board of Directors. The reasoning was that since the Board had Fiduciary Responsibility to Kids Central Inc., it seems reasonable that the Comptroller be under their direction. The organizational chart if approved would be effective beginning January 1, 2019.

A motion was made by Ida Mullins to approve the change in organizational chart. The motion was seconded by Bill Dotson. Motion passed.
