Darrell stated that 2011-2012 was the first year of our new management system with changes to our Senior Management Staff, which includes the Executive Director, Comptroller, Assistant Director of Education Services, and Assistant Director of Child and Family Services.

Darrell expressed thanks on behalf of the Board to Teresa Adkins, President of the Board of Directors for the past four years, and to Sue Coleman, Chairperson of our Policy Council for a job well done.

Darrell ended his report on the State of the Company by reporting that the "state of our company is very good and our future is unlimited."

All business of the corporation was tabled until the January meetings to enable our Board and Policy Council to enjoy lunch and fellowship with each other.
