Joint Meeting of Board of Directors and Policy Council

June 19, 2007

The Kids Central Incorporated Board of Directors and the Policy Council met on June 19, 2007 at the Kids Central Administration Office.

Donald Baker called the meeting to order at 11:00 a.m.

Minutes:

Minutes of the previous Board of Directors meeting were presented. Without any changes or comments, Ed Hutchinson made a motion to accept the minutes as written. Shirley Rogers seconded the motion. Motion carried.

Minutes of the previous Policy Council meeting were presented. Without any changes or comments, all members agreed to accept the minutes as written.

Financial Report:

Lisa Barton stated that we have been having a problem with postage for the 9 x 12 envelopes we use to mail packets to the Board and Policy Council members. We have since found the problem and have made a change to our postage machine.

We received a letter stating we have been approved for the \$35,000 Early Head Start grant and have received approval of our COLA grant. We can now re-appropriate funds to purchase a 28-passenger bus.

We are still closing out the year. We still have two payrolls and payables to post and figure on less than \$10,000 left.

We have received approximately \$175,000 in-kind than we needed for the year. Our staff has done a tremendous job.

The Certificate of Deposit the Board of Directors has is up for renewal. BB&T has the best rate of 5.1% for seven months. Lisa states she would like to add \$13,000 of program income to the CD, which, at renewal, should have a balance of approximately \$28,000, and renew the CD with an amount of approximately \$41,000.

George Aichel made a motion to have the balance of the CD at renewal and add \$13,000 of program income and renew at BB&T at a rate of 5.1% for seven months. Jim O'Quinn seconded the motion. Motion carried.

Installation of Board Members and Officers:

Darrell Edwards stated that today, Board Members and Officers for the 2007 – 2008 Board would be installed. Darrell read the oath to members of the Board of Directors. All members affirmed their oaths. Darrell then read the oath to the Officers of the Board. All Officers affirmed their oaths.
