Board of Directors and Policy Council Meeting

June 12, 2012

The Board of Directors and Policy Council of Kids Central Incorporated met June 12, 2012 at Kids Central's Administration Office. Teresa Adkins, Board of Directors Chairperson, called the meeting to order at 11:05 a.m.

Board of Directors Minutes:

Teresa Adkins presented the minutes of the previous Board meeting (May 15, 2012). With no comments or corrections, **Ronald Kendrick made a motion to accept the minutes as presented. Dave Belcher seconded the motion. Motion carried.**

Policy Council Minutes:

Sue Coleman presented the minutes of the previous Policy Council meeting (May 9, 2012). With no comments or corrections, **Carolyn Mullins made a motion to accept the minutes as presented. Cassandra Cline seconded the motion. Motion carried.**

Finance Report

Christy Fleming presented the Board and Policy Council members with a copy of preliminary financial statements. She reports that due to the time frame, she is trying to close out the month of May, along with trying to close out the fiscal year and begin a new fiscal year. She reports that we are still drawing money for May's bills. She drew \$364,000 for the month, with \$233,000 for the operating account and \$130,000 for payroll. A copy of the check register was included with the financial statements.

We have received our 2012-2013 award letter dated May 29, 2012. We have been awarded a budget amount of \$3,712,439.

As presented previously, we have been granted a 0.72% COLA increase effective June 1st, and we would like to add the additional .28% to bring the increase to 1%. **Policy Council - Carolyn Mullins made a motion to approve the addition of .28% to bring the total increase to 1%. Brittany Mullins seconded the motion. Motion carried. Board of Directors – Dave Belcher made a motion to approve the addition of .28% to bring the total increase to 1%. Thomas Williams seconded the motion. Motion carried.**

Because of this COLA increase, the pay scale must be updated to include this amount. **Board member Thomas Williams made a motion to approve the 1% increase to the current pay scale. Dave Belcher seconded the motion. Motion carried.**
