Staff Reports

• <u>Finance Report.</u> Christy Fleming presented the financial statements for November 2012. She reports that the financials for December are not completed due to the date she receives the statements from the bank. There wasn't enough time to complete December's prior to the meeting. She reports that for October, we drew down \$330,000 of which \$152,000 was accounts payable and \$178,000 was payroll.

Christy informed the Policy Council that we have still not received word regarding our worker's compensation. A representative from Synergy met with Christy on December 21st and they have been to visit our office and next door. We hope to hear something from them soon.

Our budget workshop will be held January 22 at 10:00 a.m. Everyone is invited to attend. Also, our first safety meeting will be held with staff on February 22.

• <u>Enrollment and Attendance</u>. Lisa Bentley reported that we are fully enrolled and we have an active waiting list. Our attendance for December was down due to a short the holidays and there were a lot of sickness.

• <u>Education</u>. Tammy Mullins reported that home visits are being scheduled for the end of January. The centers are continuing to go on the field trips. We recently had a Teacher resign and are in need of a qualified Teacher, a Bus Driver for Appalachia and Monte Vista, and a Substitute.

• <u>Disabilities</u>. Terry Gentry stated that there are a lot of IEP meetings being held. Early Head Start is focusing on recruitment at this time.

• <u>Nutrition</u>. Mary Collins was not present at today's meeting, however Darrell reported that everything is going good in the nutrition department.

• <u>Family Involvement</u>. Lindsey Sturgill reports great involvement during family days. She stated that attendance is high and she is getting lots of feedback from families. She is currently beginning to plan the year-end blast. It will be located at Bullitt Park in Big Stone Gap again this year. Kasey's Academy will be taking a trip to the Knoxville Zoo in April.

• <u>Health</u>. Stephanie Purvis reported she is conducting re-screenings for the children. Some parents are receiving follow-up letters explaining the necessary health documents that are needed for children's files.
